## 1 INTRODUCTION

### The Darling Downs Hospital and Health Service (Darling Downs Health) has now completed a health service plan for the next ten years.

The purpose of health service plan is to support the Chief Executive and Board to make decisions regarding the development of services across Darling Downs Health, by exploring the implications of service options for hospitals within Darling Downs Health based on future projections for health service activity and capacity requirements. The projected requirements for Toowoomba Hospital (TH) are critical given the physical constraints of the existing site and infrastructure and the need to maintain the achievements of the past five years including timely patient care to specialist outpatient clinics, elective surgery, emergency care, endoscopy and dentistry services while achieving a balanced financial budget.

The purpose of the Health Service Plan Background Paper (this paper) is to 'set the scene' for future planning stages, and inform the development of the planning scenarios (additional to the 'no change' planning scenario) as outlined in the accompanying paper 'Health Service Plan Activity and Projections'. Facilities not co-located on a public hospital campus such as Baillie Henderson Hospital, Toowoomba Community Care Units and Mt Lofty Heights Nursing Home (residential aged care) are not featured in the Background paper facility profiles.

Information presented within this paper is to be read in conjunction with the key planning considerations identified through the staff and community engagement process facilitated by Darling Downs Health and Deloitte and documented by Deloitte in the Darling Downs Health Consultation Report for the Health Service Plan 2018-2028 (the consultation report).

Those planning considerations of a strategic nature that are prevalent within the consultation report are:

- Interest from the clinicians to pursue opportunities for different approaches to health care delivery by including increased emphasis on health promotion and early intervention.
- Opportunities to develop capability and capacity in major rural areas within Darling Downs Health.
- Community characteristics impacting health care access, health needs and expectations identified for example; socio-economic challenges, remoteness and impact on potentially preventable hospitalisation (PPH) and length of stay.
- Concern regarding ability to meet projected demand for services from Darling Downs Health residents (Intra-HHS patient flow patterns)

This paper acknowledges the role of Darling Downs Health as a specialist referral hospital provider for South-West Queensland. For this reason, detailed analysis of inter-HHS flow patterns has been undertaken to inform opportunities for collaborative service planning with surrounding HHSs, improve the sustainability and quality of health services, and cooperatively enhance the role of the Darling Downs Health services throughout the Darling Downs Health area.

## 1.1 PLANNING AND POLICY CONTEXT

Refer to Appendix 5 summary of Planning and Policy documents both National and State that inform the focus for health service planning.

#### Notes:

A glossary of key words is provided at Appendix 3.

For providing a broad overall understanding of the future use of health services by residents of Darling Downs Health, projections based on Acute Inpatient Modelling (AIM) have been used for all Service Related Groups (SRG) in this paper.

Renal dialysis has been specifically excluded due to the distorting impact that the very large volume of these separations has on the overall analysis. Projections for renal dialysis have therefore been provided separately.


This paper assumes reader knowledge of the full suite of services offered at Darling Downs Health as detailed within the review and the Darling Downs Health Organisational Chart at Appendix 4. It should also be noted that there are alternative Queensland Department of Health endorsed projection methodologies (other than AIM) for mental health, interventional cardiology, cancer, qualified neonates and endoscopy. For interventional cardiology, cancer and endoscopy services the endorsed methodologies adjusted for the additional volumes of non-admitted activity that are not included in AIM. Population based methodologies are used for qualified neonates and mental health. These endorsed methodologies will be used to develop specialty specific projections during the next phase of the planning process. Percentages shown throughout the report are for information, these percentages are rounded and so may not total 100 percent in all occasions.

## 2 CATCHMENT ANALYSIS

The Darling Downs Hospital and Health Service (Darling Downs Health) services an area of approximately 88,650 square kilometres servicing approximately 5 percent of the total Queensland area.

Local Government Areas serviced within the Darling Downs Health area are: Cherbourg Aboriginal Shire Council, Goondiwindi Regional Council, South Burnett Regional Council, Southern Downs Regional Council, Toowoomba Regional Council, Western Downs Regional Council and part of the Banana Shire Council (community of Taroom). Darling Downs Health catchment area includes 34 Service Area Level 2 (SA2) within six Service Area Level 3 (SA3) including Darling Downs – East, Goondiwindi, South Burnett, Southern Downs, Toowoomba and Western Downs. Refer Figure 1 and Table 1.

The Darling Downs Hospital and Health Service area covers a predominately rural region extending from the New South Wales border to Glenmorgan in the west and Taroom in the north and includes the regional centre of Toowoomba. Darling Downs Health provides public hospital and healthcare services from 28 facilities, which includes one large regional referral hospital, three medium sized regional hub hospitals, twelve rural hospitals, three multipurpose health services, one community outpatient clinic, six residential aged care facilities, one community care unit and an extended inpatient mental health service.

## 2.1 FACILITY CATCHMENTS DEFINED

While planning regions align with Darling Downs Health catchments, there are a range of factors that influence how and where people access services.

These factors include the availability of hospital based medical services in local areas relative to local needs (for example, people may travel to a service geographically associated with the location of where they work), medical primary care historical referral practices, the centralisation of services offered at tertiary level facilities (such as medical specialties), and public transport and road networks.

In 2016/17 there were 69,289 Darling Downs Health hospital separations. The majority (37percent) of the people who accessed the services were from Toowoomba region, followed by Southern Downs (15 percent) and Darling-Downs East (14 percent). Approximately 11 percent of the of the total activity came from other HHS/ interstate residents.



Due to the vast area serviced by Darling Downs Health each local planning area has a number of facilities within its catchment area. ## 2.1.1 DARLING DOWNS - EAST PLANNING REGION

The Darling Downs – East planning region consists of six public facilities namely; Dalby Hospital, Karingal Residential Aged Care Facility, Jandowae Hospital, Millmerran Hospital, Oakey Hospital and Dr EAF McDonald Residential Aged Care Facility.






