Darling Downs Health Board Meeting 30 – 31 August 2021

Summary of the key issues discussed, and decisions made by the Board

A meeting of the Darling Downs Health Board (the Board) was held on 30 – 31 August 2021 at Chinchilla Hospital.

Monday 30 August 2021

The Board took the opportunity to tour Miles and Tara Hospitals on Monday 30 August 2021. During their site visits they met with staff members and thanked them for their dedication to providing excellent patient care and health services to the community.

Tuesday 31 August 2021

The Board meeting was chaired by Mr Mike Horan and attended by eight (8) members of the Board. A range of matters were dealt with at the Board meeting including:

- The resignation of Dr Peter Gillies who has accepted the Health Service Chief Executive (HSCE) role at Sunshine Coast Hospital and Health Service. The Board thanked Dr Gillies for his service to Darling Downs Health (DDH) over the past 12 years.
- The Board approved the temporary appointment of Annette Scott, Silver Commander COVID-19 Response as acting HSCE until the recruitment process is finalised.
- The Board received and noted reports provided by the Board Executive, Safety and Quality, Board Audit and Risk and Board Finance Committees.
