Darling Downs Health Board Meeting 25 August 2020

Summary of the key issues discussed and decisions made by the Board

A meeting of the Darling Downs Health Board (the Board) was held on Tuesday 25 August 2020 at Stanthorpe Hospital. The meeting was chaired by Mr Mike Horan and attended by nine (9) members of the Board.

Dr Dan Halliday, Medical Superintendent and Ms Pauline Maude, Director of Nursing attended the meeting and presented an overview of activity, workforce, challenges, opportunities and innovations at Stanthorpe Hospital.

A range of matters were dealt with at the Board meeting including:

- The Board received and noted reports provided by the Board Executive, Board Finance, Board Audit & Risk and Board Safety & Quality Committees.
- The Health Service Chief Executive (HSCE), Dr Peter Gillies provided a comprehensive report to the Board on the operations, activity and governance of the Darling Downs Health (DDH) in line with identified service priorities and performance indicators.
- The Board discussed the Chief Finance Officer's report for July 2020 and noted the current financial position of the health service. The Board noted contract negotiations for 2020-21 have been finalised.
